	<u>Chairman's Welcome and Public Forum</u> – the Chair welcomed those present with a particular warm welcome to the members of the public.

PR2/2015	<u>Apologies for Absence</u> – Cllrs. Jenkin and Webb (both with work commitments).		
PR3/2015	<u>PROW Issues</u> – Minute PR40/2014 refers. a. <i>PROW/207/124</i> – March Public forum refers. Cllr. Henwood reported a site meeting had been held with representatives from Cormac. It had now been agreed that CC will carry out extensive repair works. It is understood that work will be completed by the end of this financial year. b. <i>Public Byway, Halgarrack Farm</i> – no update was available. c. <i>PROWs 113 & 114</i> – Mr Sanders had been asked to give an update, regarding clearing the paths, within the agreed budget figures, but had failed to do so. d. <i>PROW 100</i> – Members received an update, regarding: i. <u>Obstruction</u> – Mr Bayes reported no action had been taken on the path. He is working closely with Ms Linda Holloway on a programme of enforcement work across West Cornwall and will progress the Crowan 100 issue when time permits. ii. <u>Bog Area</u> – Mr Sanders had been asked to give an update regarding construction of a board walk, within the agreed budget figures, but had failed to do so.
