Henwood reported he is talking to the family. 50M of the path is not registered.</p> <p>b. <i>PROW/207/38/1</i> – the South entrance had been padlocked shut with 'private property' signs, and the North entrance blocked by aggressive dogs. Cllr. Henwood to talking to the landowner. In the hands of CC.</p> <p>c. <i>PROW/207/50/3</i> – replacement stile and gate are in place. Highways to replace gateway into garden – complaint incoming. Work ongoing with CC.</p> <p>d. <i>PROW/207/50/4</i> – the signage missing from the road is in hand. Work ongoing with CC.</p> <p>e. <i>PROW/207/51/2</i> – Cllr.
