EQUALITY AND DIVERSITY POLICY

1 INTRODUCTION

1.1 The Equality Act 2010 came into force in October 2010. The legislation covers a prescribed set of protected characteristics including age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex and sexual orientation.

It also covers prohibited conduct including discrimination, adjustments for disabled persons, victimisation and harassment; services and public functions; premises; employment; contracts; and, advancement of equality. The latter provision specifies a public sector equality duty.

2 **POLICY**

- 2.1 The Parish Council is committed to promoting equality and diversity, providing an inclusive and supportive environment for all. In the implementation of this policy the Parish Council will:
 - 2.1.1 Ensure that people are treated solely on the basis of their abilities and potential, regardless of race, colour, nationality, ethnic origin, religious or political belief or affiliation, age, gender, gender reassignment, marital status, sexual orientation, disability, socio-economic background, or any other inappropriate distinction.
 - 2.1.2 Promote diversity and equality and value the contributions made by individuals and groups of people from diverse cultural, ethnic, socioeconomic and distinctive backgrounds.
 - 2.1.3 Challenge inequality and less favourable treatment wherever practicable.
 - 2.1.4 Promote greater participation of under-represented groups by encouraging positive action to address inequality, promote an environment free of harassment and bullying on any grounds in relation to all staff, Councillors, contractors and visitors attending the Council's offices or meetings.

The task of promoting social inclusion, tackling discrimination and encouraging equal opportunities are key issues for Crowan Parish Council and the Council is committed to:

- 2.1.5 Eliminating unlawful discrimination, harassment and victimisation.
- 2.1.6 Advancing equality of opportunity between different groups.
- 2.1.7 Fostering good relations between different groups.

- 4.1.2 Gender reassignment.
- 4.1.3 Disability.
- 4.1.4 Sex.
- 4.1.5 Sexual orientation.
- 4.1.6 Age.
- 4.1.7 Religion or belief.
- 4.1.8 Pregnancy and maternity.
- 4.1.9 Marriage and Civil Partnership.

5 **OBJECTIVES OF THE POLICY**

- 5.1 To improve delivery, information and access to services we will:
 - 5.1.1 Ensure all employees, contractors and users of our services are informed of our Equality and Diversity Policy. INCL copy in tender pack

- 5.1.2 Apply equal opportunities principles to work undertaken for the Council by external contractors, other organisations in receipt of Council funding and in work with our partners.
- 5.1.3 Rectify any elements of our work which will have the potential for discrimination and prejudice.

5.2 Responsibility and Liability

- 5.2.1 All members of staff and Councillors remain personally responsible for ensuring that they act within the law.
- 5.2.2 The Clerk is responsible for ensuring that staff perform their duties in a lawful manner and that proper training and support is provided accordingly.
- 5.2.3 In certain circumstances the Parish Council could be vicariously liable for actions carried out by staff purportedly in the Council's name.
- 5.2.4 Any member of staff or Councillor may be personally liable if, whilst on Council business and despite guidance and training from the Council, they behave illegally in respect of the Equality Act 2010.

6 **EMPLOYMENT**
